



WUNF-TV Asheville, North Carolina had a problem. They were repacked from channel 25 to channel 20 – but there was no way to transport channel 20 equipment to their Mt. Pisgah transmitter site. The site can be reached via a 1.6km walking trail, or a funicular railway. The State of North Carolina required the railway be shut down for safety violations, and the site owner (WLOS-TV, which was not repacked) doesn't seem interested in making prompt repairs.

WUNF proposes to abandon the Mt. Pisgah site. They plan to take over WYCW's existing channel 45 site on Pinnacle Mountain near Westbridge. There's a road to this site:) WYCW sold its channel in the auction (it hopes to share with someone else) leaving the site available.

WUNF was a two-site Distributed Transmission System installation. The second site will remain in operation on channel 20 from its location behind the Cherokee, N.C. Police Department. I cannot explain the 332m reduction in antenna height. Either the old or new height figure is wrong.

We have seen a number of sharing agreements filed where a currently full-power station will share on a Class A (low-power) host. The full-power station will lose considerable area coverage. However, in several cases the number of *people* reached will increase substantially. (there are far more people in ten square miles of New York City than in ten square miles of northwestern New Jersey!)

This month we have one that goes the other way around. Full-power WGBH-TV will host Class A WFXZ-CD. WFXZ will receive a large increase in coverage. I might guess (this is just a guess) they will pay WGBH nicely for access to that full-power transmitter. The increase may be short-lived; WGBH volunteered to be repacked to low-VHF channel 5.

A flip-flopping weather pattern during September – the first-half quite hot out west and unseasonably chilly out east – followed by recent record warmth around the Great Lakes – hasn't led to an abundance of tropo, even with a freakishly active pipeline from the tropics with the U.S. landfalling Hurricanes of Harvey and Irma.

Strong high pressure on the 22nd did lead to some Lake Erie-enhanced tropo. Bill Hepburn in ON had DTV decodes from Philadelphia during the event. We hope for some more opportunities in October before the weather turns prohibitively cooler in the north.

Enid, OK

** OKLAHOMA. OK tropo morning of August 6 propels some low-power OKC DTV to Enid. Decoding at 1452 UT are: RF 36, KUOK-CD; RF 42, KBZC-LD;

At 1505 UT, RF 21, KTOU-LD with its six subchannels:

21-1. HSN

21-2, SBN Live per bug UR

21-3, HSN-2

21-4, JTV HD

21-5, totally black screen and no audio!

21-6, ? another infomercial

Also in are full-powers on RF 26, KTEN ``10`` Ada; on RF 20, KQCW-HD ``19-1``, but exhibiting a KOTV 6 LR bug from Tulsa.

KOCB RF 33 OKC is not decoding, implying some DX QRM to it. Most likely probably KUVN Garland TX among lots of other Texans and a few Okies, Kansies.

Also Bad DTV signals not decoding on RF 19, 12 and 11 until 1500 UT.

And once again, the last living NTSC transmitter around here, A48, KOCY-LP with Estrella TV, weak but steady and NOT cutting off the air! snowy color signal. Ahhh, snow, about to become a past-thing on the TV screen.

(Unfortunately the autoscan on my main Sanyo screen previously picked this up, and thus refuses to display same Estrella TV as virtual 48-1 of RF 29 KTUZ, even when manually entered! Since 29's virtual channels 30, 36 and 48 are not consecutive, tuning upward does not work either.) All gone by 1552 UT (Glenn Hauser, Enid, DX LISTENING DIGEST)

** OKLAHOMA. RF 17 DTV, August 11 at 1435 UT and the following two sesquihours at least,

K17JN-D, Enid's only local TV station unknown to most inhabitants, had been six subchannels headed by 3ABN, but now, nothing but 17-6 with a total green screen and silence, PSIP now reading "test". About to switch to other inputs?? "No signal" says my Sanyo screen except when directly tuned to 17-6, but the Zenith box confirms the usual signal level for -1 thru -6 even tho "no signal" too and all PSIPs 1-5 blank, not even the callsign on 17-1 as originally. I believe K17JN-D had suffered some breakup during recent storms so maybe they got hit, or their satellite downlink reception interrupted.

RF 17, Aug 11 at 2320 UT recheck, K17JN-D Enid is almost back to normal with 5 different 3ABN subchannels on 17-1 thru 17-5, but 17-6 remains greenscreen only as ``test``. Ditto Aug 12 at 1458.

Aug 12 at 1814 UT check, my Sanyo only gets 17-6, even when I enter 17 or 17-1, but the Zenith STB gets all six, strange. Current PSIPs (not necessarily valid 24/7 with this network): 17-1, K17JN-D, bug LR: 3ABN (classical orchestral concert! But only an interlude during a 2016 sermon referencing Oscar Wilde) 17-2, 3ABN-PR, bug LR: Proclaim! 17-3, AmFacts, bug LR: AFTV 17-4, 3ABN-ES, bug LR: 3ABN + illegible [Spanish] 17-5, Hope201, bug LR: illegible triangular logo [since not on HD screen] 17-6, test, green (Glenn Hauser, Enid, DX LISTENING DIGEST)

- ** OKLAHOMA. Tropo is up from Tulsa area, morning of August 15: Tulsa DTV RF channels decoding are 20, 22 and 28, with bad signals from most of the others. More interesting are the OKC channels which are *not* decoding due to DX QRM: 33, maybe due to KNWA, 820 kW in Rogers AR; and 29, maybe due to KTZT-CD, 10 kW in Tulsa. More low-powers on both inhabit OK, AR, KS, MO (Glenn Hauser, Enid, DX LISTENING DIGEST)
- ** U S A. Morning of August 18, tropo is up from eastern OK and Arkansas. William Hepburn's map for 15 UT shows a Level 8 extreme tropo blob in western Arkansas, around a tiny Level 9 spot; progressively less toward us, as usual on the edge of an opening.

Most UHF and hi VHF channels display at least a Bad signal on the Zenith box and/or Sanyo TV. Many otherwise OKC-area Good signals are either broken up or bad due to DX interference: RF 7, 13, 15, 17, 27, 29, 33, 46.

OKC low powers are making it: 41 KBZC-LD, 36 KUOK-CD. Also still past 1612 UT, the only NTSC analog, 48 KOCY-LP, with Don Cheto and his prancing girls on Estrella TV.

RF 18, KFSM-DT Fort Smith AR is the only solid DX, as 5-1 with CBS; 5-2 with KXNW-DT, and 5-3 with Antenna TV; weakening during the 15-16 hour (Glenn Hauser, Enid OK, DX LISTENING DIGEST) DTV

- ** OKLAHOMA. RF 7, Aug 25 after 1400 UT, astounding that KOCO ``5`` is the only OKC station with continuous coverage of flash flooding in the City --- KFOR, KWTV, KOKH and KAUT remain with regular programming, tho there might have been cut-ins. KOCO already had local news hour, extended at least until 1555 UT. Heavy rain was provoked already by Harvey pushing precip this way even before eye hit Texas; Enid remained dry (Glenn Hauser, OK, DX LISTENING DIGEST)
- ** OKLAHOMA. RF 27, Wed Aug 23 at 1800 UT, KFOR-TV flashes its translator ID roster, again too swiftly to read or retain any of it. Maybe about 6 or 8 of them? Surely there are more. These could be only the O&Os? Someday I will manage to capture this on tape for leisurely legibility, but they don't do it every day at this time (Glenn Hauser, Enid, DX LISTENING DIGEST)
- ** OKLAHOMA [and non]. RF 42, Aug 26 at 1426 UT, area tropo is up, visiblizing KBZC-LD from OKC with [and rabbit ears listings]:

42-1 football [American Sports Network]

42-2 fishing [Tuff TV]

42-3 BUZZR [BUZZR]

42-4 GetTV [GetTV]

42-5 QVC [QVC]

42-6 Q2 [QVC2]

42-6 QZ [QVCZ]

42-7 ShopLC [ShopLC]

GetTV used to be on a full power sub-station, forget which. KBZC used to have only 6 channels. No sign of the OKC LD on channel 21.

RF 36, KUOK-CD also decoding at 1450 UT Aug 26, Univisión = KDCU 31

RF 31, KDCU, Derby/Wichita KS with Univisión RF 45, KSNW Wichita, but no other Kansans breaking thru

RF 48, KOCY-LP, OKC, Estrella TV, still the only NTSC left around here, color snowy weak & steady (Glenn Hauser, Enid OK, DX LISTENING DIGEST)

The KTUL transmitter on RF24 is located just north of McAlester.

It's a Digital Replacement Translator. From a technical standpoint, it's the same as an ordinary translator. From a regulatory standpoint, it's intended to fill gaps -- areas where the station reached in analog but doesn't in digital. KTUL has an application on file for another one, also on channel 24, located between Bartlesville and Coffeyville KS.

Digital Replacement Translators are part of the main station's license. They cannot be sold independently of the main station and cannot carry any programming besides a 100% relay of the main station. They do not get their own call letters -- the call letters of the channel 24 transmitter are also KTUL. == (Doug Smith W9WI, Pleasant View, TN EM66, WTFDA gg via WORLD OF RADIO 1884, DXLD) Yet "city" listed as Tulsa, not McAlester. which I suppose Doug determined from the coordinates, which I did not inspect (gh, WORLD OF RADIO 1884, DXLD)

** U S A. Area tropo from some Tulsa, Wichita stations, morning of Saturday July 1; at 1423 UT. KWCH Wichita on both RF 12 and RF 19, but better on 19: 12-1 KWCH-DT with local news; 12-2 KWCH WX; 12-3 Heroes, old drama reruns, new subchannel for this? Faded out from 19 by 1507.

KOKI-TV, RF 22, 23-1 from Tulsa with local news

No Es TVDX (nor FM) to report this month, July! I have just about given up hope for ever getting any double-hop analog TV from Central or South America, despite my antenna aimed that way and long hours of watching snow on channel 2. Not much tropo either, just this from the area:

** OKLAHOMA. After hitting the reset button by mistake, I have to reprogram my Sanyo TV screen: this model does not allow DTV channels to be added individually, only auto-programming. So away we go circa 0430 UT July 6: it detects 42 channels, and flipping thru them, discover some major ones got skipped, like KTUZ-29 "30". But to my great surprise, tropo must be up, so KTOU-LD on RF 21 is now included from OKC. If I autoreprogram it again during dead conditions, will lose it.

Here's how its six subchannels are labeled:

21-1, HSN

21-2, SBN

21-3, HSN2

21-4, ONTV4U but LR bug says JTV

21-5, KTOU-LD, but only broadcasting black screen with some flashes

21-6, KTOU-LD, infomercial with no bug

Here what Rabbitears.info shows for KTOU:

display physical video audio call sign network/programming 21-1 21.1 480i DD2.0 HSN HSN

21-2 21.2 480i DD2.0 SBN SonLife +

SAP Audio Icon

21-3 21.3 480i DD2.0 HSN 2 HSN2

21-4 21.4 480i DD2.0 ONTV4U Infomercials

21-5 21.5 480i DD2.0 KTOU-LD Gun TV

21-6 21.6 480i DD2.0 KTOU-LD [Blank]

It's only 4 kW ERP, with signal slightly direxional toward Enid.

BTW, KUOT-CD on RF 19 is slated to move to 21, apparently supplanting

KTOU: because KAUT 40 goes to 19. Others repacking in Market 50: KOPX 50 to 18; KOCM 46 to 16; KOHC-CD 45 to 31; KWTV 39 to 25.

The reprogramming also picks up KETA 13, with the four OETA subchannels NOT breaking up. Tropo boost may account for it, and I fear when that subside, it'll be back to jerking around, presumably due to QRM from the second harmonic of KNID 107.1 on 214.2 MHz. I can also barely get OETAs in clear on a third set with rabbit ears only.

{No, continues to be almost break-up-free on this antenna, and fortunately because Suddenlink Cable has reverted to the problem before two months ago: NO stereo, and mandatory DVS imposed on OKLA. I've notified OETA again and they are working on getting it fixed}

My HD screen is also receiving RF channel 48 in analog, a weak but steady, snowy but color-confetti pixure from KOCY-LP, with Estrella Network, 15 kW ERP. Also noisy analog audio. That's the one I have previously seen on my B&W analog TV and other antenna, cutting on and off the air, but nothing lately, and I still see no trace of it there.

This is the *first* time I have seen any NTSC weak transmitted video on my HD Sanyo screen! At 0459 UT July 6, an anti-cable promo for all the stations and networks one can get off the air. Otherwise, programming is infomercials, at late-night, probably usual sex enhancement devices or pills.

However, at 0511 UT, suddenly goes to black, and floating around the screen in small font are NO SIGNAL, and NO PROGRAM. This is obviously produced at the input to the ch A48 transmitter, not by my receiver.

Disappears at 0523, but back at 0524, probably a brief fade below reception threshold here.

So anyhow, KOCY-LP on analog 48 is still there, sometimes, but a big mess if anyone would actually try to watch it, rather than as a full-power virtual 48 subchannel of the KTUZ RF 29 transmitter. The KOCY-LP ID on the hour showed 48-1, even though it was seen in analog! (Glenn Hauser, Enid, DX LISTENING DIGEST)

** OKLAHOMA. KFOR-27, ``channel 4``, OKC, July 6 at 1800 UT ID slide at ToH shows a bunch of translators, as stations are required to do periodically. It's only up for a few seconds, impossible to read, let alone retain. Note to self: have tape rolling next time, ready to freeze and photo, in case the list be accurate and up-to-date. I do so July 8 at 1800: NO SHOW, between programs, not even a legal ID for KFOR itself! Does this appear at random times? Maybe a translator list on the website http://kfor.com --- of course not. Even searching on `translator` gets nothing but some news stories mentioning that word, not talking about TV relayers! (Glenn Hauser, Enid, DX LISTENING DIGEST)


** OKLAHOMA. RF 42, July 11 at 1430 UT, 4-channel station decodes, as tropo is enhanced from eastern OK, also bringing in Bad signals on many other UHF channels, correlating with Tulsa area market. Only other decode is RF 26, KTEN ``10`` Ada. 42 might have been the LD in OKC, but not now. I survey what's contained within:

41-1 KMYT-TV, 41-2 GetTV, 41-3 GritTV, 41-4 HNI as per PSIP, but ``H&I`` shown in program promo, during an old Andy Devine B&W movie.
But contrary to schedule showing Wagon Train at 9-10 am CT, per http://handitvnetwork.com/schedule/

Means Heroes & Icons. We don't get this in OKC market, or local cable. Site is halfway between Tulsa and Muskogee with 900 kW ERP. KMYT MyTV will be repacked to RF 34 (Glenn Hauser, Enid, DX LISTENING DIGEST)

KDCU-DT, RF 31 and 31-1, Univision with U bug and e|i bug for kidvid, classic Disney toons. Wichita market; no subchannels found

KSNW-DT, RF 45, 3-1; also 3-2 Telemun[do], 3-3 Ion, Wichita (Glenn Hauser, Enid OK, DX LISTENING DIGEST)



All Hands On Deck Across Fort Myers Stations As Irma Arrives

As Irma moves up Florida's West Coast, all stations in Fort Myers are streaming coverage.

The powerhouse stations in the market, <u>WBBH</u> and <u>WINK</u>, have taken very different approaches on coverage for now.

WBBH has teamed up with its sister station WZVN, the ABC affiliate in the market, to cover the storm across both stations and streaming coverage on YouTube.

NBC 2 chief meteorologist **Robert Van Winkle** and ABC 7 chief meteorologist, **John Patrick**, are tracking the movement of the storm across the area from Naples to Port Charlotte. It appears reporters and photographers



who are covering the storm from across the area have taken shelter in a safe place. There have been few live reports in since the storm picked up but they are using live cameras to show viewers what is happening outside.

Van Winkle was on the forefront of forecasting Hurricane Charley in 2004 when it hit the area.

<u>WINK</u>, the CBS affiliate in the area, is also streaming coverage on their <u>website</u>. Anchors **Chris Cifatte** and and **Lois Thome** are leading the coverage on the anchor desk with the help of chief meteorologist **Jim Farrell**. As for 2pm, they are still utilizing reporters for live reports from hotels across the area and the live radar of Irma rolling in the lower right moving graphic.

Derek Beasley is handling coverage on WFTX, the Fox affiliate in the market.

Hurricanes are a part of life along the Gulf and Atlantic coasts, with Florida being the bullseye right inbetween them. Always need to be prepared!

This is the third time I've been in a hurricane. The others were Gloria (in NY, when I was too young to remember) and Wilma (just after I moved here). I had my radio and recorder with me to bandscan before, during, and after the hurricane. I'll be posting these clips to YouTube soon.

Steady Rockin' in Fidel's Backyard

If you turn to a fellow seasoned Trooper and ask them about their experiences with the American Forces Network chances are they will mention the corny Public Service Announcements or the over-the-top news reporters. Anywhere there is American boots on the ground AFN will be there, always reminding Troopers and families, "Don't Shake the Baby!" U.S. Naval Station Guantanamo Bay, Cuba has a radio branch of the Armed Forces Network that is unique to here alone, and many know it as its more popular title – Radio GTMO.

"The thing that makes GTMO *GTMO*, especially to the people here, is Radio GTMO. It is the sound of the island," said Petty Officer 1st Class Monique Meeks, a mass communications specialist and the manager at Radio GTMO. "We used to be the only thing here."

The radio station itself sits on a secluded peninsula surrounded by large radio dishes and calm beaches. AFN Guantanamo Bay was founded in 1947 on a different part of the island and went under the name WGBY. Since 1964, Radio GTMO has called that building home. Within its doors sits two important components; the U.S. Navy's Mass Communication Specialists who are responsible for running the station and entertaining Troopers and the largest record collection of all AFN radio stations in the world.

"We can either make or break Troopers' spirit and morale," said Meeks. "If my Sailors are doing their job well, they're getting the word out about events on the island and providing an entertainment value for the base."

Providing a morale boost and bringing a little piece of home to Troopers here has been the goal of AFN, and especially Radio GTMO, since the beginning. The station owns three tune-in radio signals in the area. There is 102.1, NSGB's and Joint Task Force Guantanamo's specific talk radio, 103.1, the country music station, and AM 1340, a provided talk radio. Being able to broadcast three separate signals is something only Radio GTMO can do.

"We offer that extra moral boost, even if it's making fun of our cheesy commercials we come up with," said Petty Officer 2nd Class Zachary Anderson, a mass communication specialist. "One of our main missions is command information. Radio is one of the best mediums in the fact that it is immediate."

Radio GTMO is one of the oldest military radio stations and sits on the oldest military base not on U.S. soil, so it is no surprise it has its hidden treasures. The greatest treasure though is the 20,000 piece vinyl record collection it protects within its walls.

"We have the only active record collection in the entire Department of Defense," said Anderson. "The coolest thing is that we can still play them. If I wanted I could go in the booth and throw a record on the turntable and play it."

Radio GTMO almost faced the same fate as many AFN stations around the world when digital music reared its head, destroying the outdated record collection. Thanks to some determined MCs back in the day, the decision to destroy them was halted and the records became a physical and permanent part of GTMO history.

"It's history, musical history. One of the best things is when I bring a tour group in. There are some people that just light up and get so excited when they see our record collection, it is such a tangible medium. You can pick a record up and just hold it, it's so tactile and it's great to see people react to them so positively," said Anderson.

The radio station is not there to only provide audible entertainment, its doors are open to whomever visits NSGB and wants to experience the unique history or maybe just grab a Fidel Castro bobble head.

"You know we have the tag line 'Rocking in Fidel's Backyard,' it is something iconic to Radio GTMO, people come here to be part of that experience," said Anderson. "We are not just a radio station, we are a part of the community and Guantanamo Bay history."
