If there were winners this season, I'd say they were those in the Pacific Northwest and west in general. And if there were losers, they'd be in New England. Most of the Es this year wouldn't get this far east. I think most Dxers would say, though, that it just was not a good year for skip and you can blame that on the sun, which has been very active this summer.

This month we are welcoming **Steve Ehrdardt** (MO) and **Bob Timmerman** (IN) back to the WTFDA. Welcome back, guys.

I have had to send back a few checks and refund some Paypal payments to those who sent renewal dues. Once again, I need to say that when a person sends in his initial \$10 for WTFDA membership, he becomes a lifetime member. Every WTFDA member reading this (and even those not reading this) are all lifetime members of the WTFDA and don't need to renew EVER. The only ways you cease being a member is if your email address bounces and nobody can contact you, or in an extreme case, if you pass away. If you email us and tell us that you want your membership canceled (as one ex-member already did), we will cancel it.

And speaking of that, we were informed by Marie Novello that her husband Jay passed away in June. We sent our condolences to her and her family. Jay lived in Wake Forest, NC.

This came from **Bill Lipis** in San Diego: I've been testing out the ATSC3.0 Zapper Box since it came out. In San Diego we only have one ATSC3 station, RF Chan. 6 a Franken FM station. Zapper Box only received Chan. 6 station ID data with NO video until a recent Zapper software update. Now I can view video Shopping Channel, picture quality is quite good. Zapper Box uses Sony RX chip, I'm told. The latest Zapper software allows the video to be detected even though channel is slightly offset (from standard spec) due to being a Franken FM/TV station. It took the Zapper folks many months to make the Franken Chan. 6 fix happen. Also, earlier Zapper hardware had been using physical in-line RF pads to be switched out depending on RF signal strength! A real pain. My guess is that they had not enabled the RF AGC stage on the Sony chip set. Zapper swapped out my earlier box and the newer box has a quite active RF AGC stage that doesn't require use of any in-line RF pads. I just wish San Diego had more than one ATSC 3 station! Hope to see more reports on 3.0. The picture color and look is quite good even at low resolution. I'll mention to you that I'm lucky that one of the main Zapper Box design guys lives here in San Diego, so I can give him feedback.

From **Ralph Strobel**: Forgot to tell you that Andy Bolin had a double hop to 95.7 KBOY Medford, OR over 1800 miles this summer. His semi-local in Effingham, IL was on low power at the time. He hasn't heard CA, but has one NV - Las Vegas on 93.1. He's still searching for AK & HI. Is there such a thing as triple or quadruple hop? HA HA! (I think the Es we had to the Azores in July could be considered 2E or possibly 3Es, at the least you could call it multi-hop -Mike) (Ralph is in Muncie, IN and Andy is in Charleston, IL)

DXing this summer has been worse than PITIFUL !! What Es I've found has been nothing but mostly relogs. Last night there was skip but was so choppy, it was impossible to get anything new. Had a few from OK TX & NM. I've only heard 8 new stations this year and that is nothing but disgusting and disappointing. (yes, it has been pretty bad for a lot of people but there has been some FM double hop in North America this summer to help ease the pain a little -Mike).

From Taylor Crain in WA posted on the Mewe group: Here it is, in all its glory. KQXY 94.1 and KYKR 95.1 Beaumont TX double-hop from the 'honey hole' spot northwest of Selah, WA 7/20/2023 in the 11am PT/1PM CT hour. 1826 and 1830 miles respectively. I still have no words for this. Listen to how strong the signals were on a *car radio*!! Pioneer Supertuner III in Hyundai Santa Fe, window antenna, 10dB FM booster.

KQXY - ID sweeper, then I come back a few minutes later, NAB PSA for saving AM radio ends, ad for Market Basket, Upside ad begins.

KYKR - Slam-dunk ID with DJ Trey Poston, out of 'I Hate Everything' by George Straight.

From John Jefferson in OR: K219BH 91.7 Burns, OR. I heard it tonight in parallel with KMHD 89.1, so their antenna replacement obviously is done. They're too weak to understand the announcer, but the jazz selection was unmistakably what KMHD had. The major problem was getting KMHD since KFAE Richland WA is in and out. 91.7, on the other hand, has only MS bursts to contend with except during ES openings. Then most of the 88-92 channels are subject to interference and 89.1 can become a battlefield. During one big opening this season, I logged KLFR Reedsport OR, 700 watts at 155 miles. As I tuned past 89.1 I heard the KLCC calls (the source of KLFR's signal). Figured I'd mis-heard but review confirmed it was "KLCC" I'd recorded. Maybe I've missed prior chances: during NPR's news they would be assumed to be KFAE; during KLCC's jazz programs I'd assume it was KMHD. Or was I hearing an impossible-to-log station (low wattage, high mountains in the way) reflecting back from the ES cloud? Fun to contemplate, no?

If any of you have checked out w9wi.com, you'll find it now completely unrelated to Dxing. This was Doug Smith's famous website but Doug reports that he was unable to get it back and now it's gone for good. Doug also mentioned that he no longer has any time to do any kind of TV or FM updating (like the information he posted on the WTFDA Forums every couple of weeks) and to not expect anything in the future. I used his information for the TV News column.

The demise of FM News presents a dilemma, whether to find someone to continue what Doug has been providing over the past years (no chance of that), do nothing at all and let it die or take FM News off into another direction. I think we'll go with door number three and see what happens. So check out TV News in this issue and give me some feedback. Feedback will determine if anyone finds the column informative or useful and gives me a good idea whether or not I continue to include it in the VUD.



Cheaper ATSC 3.0 4K TV Receivers are Coming – With a Smart Design Twist

Better broadcast TV at a lower price for any TV, and without using an HDMI port

Hidden among the sprawling booths of the big electronics brands at CES 2023 was a small bunch of displays put on by manufacturers associated with the next-generation digital broadcast TV transition currently taking place in the US.

That new digital TV standard, <u>ATSC 3.0</u> (aka NextGen TV), promises to bring advancements including <u>4K</u> resolution video with high dynamic range and immersive audio formats such as Dolby Atmos to free, adsupported broadcast TV. While those capabilities haven't yet been tapped by the ATSC 3.0 broadcast TV stations operating in 66 US markets, a footprint covering more than 50% of the country, some of the <u>best</u> <u>4K TVs</u>, including models from Sony, Samsung, LG, and Hisense now feature built-in ATSC 3.0 tuners.

CES 2023 turned out to be <u>something of a wash when it came to new TVs with ATSC 3.0 support</u>. <u>Hisense</u> seemed to be the only one championing the format, with its <u>full lineup of 2023 mini-LED TVs</u> slated to get the feature. LG announced that it would appear in the company's higher-end models like the Z3 and <u>G3</u> <u>OLED</u> sets – same as in 2022 – and the same goes for Samsung, which will provide the feature in its flagship sets like the <u>new S95C OLED</u>. Sony, meanwhile, has yet to provide detailed specs for its 2023 TV lineup and TCL hasn't announced any new TVs with built-in ATSC 3.0 tuners. The sluggish ATSC 3.0 uptake among TV makers and broadcasters alike is concerning – industry group the National Association of Broadcasters (NAB) recently encouraged the FCC to take proactive steps to accelerate the transition, presumably by amending the requirement for ATSC 3.0 broadcasters to also simulcast programs in the older ATSC 1.0 format for five years after making the transition. Even so, examples of external hardware designed for tuning in NextGen TV broadcasts have emerged.

One such example is the ZapperBox M1, a set top box with a built-in ATSC 3.0 tuner that connects to TVs using an HDMI output. But at \$250, the M1 likely cost more than most viewers will want to pay to add that capability.

Among the companies exhibiting in the NextGen TV booth at CES was Tolka, which is part of broadcast industry group Pearl TV's FastTrack for NextGen TV program, an initiative aimed at hastening the commercial development of both ATSC 3.0compatible TVs and inexpensive accessory devices for tuning in NextGen TV broadcasts. The company has created software to



power a compact USB stick-type ATSC 3.0 tuner that plugs into a set's USB port and connects to a TV

<u>antenna</u>. Such devices are being made by Atlanta-based company ADTH and should be available at retail later this year for under \$75.

Cheap external tuners can accelerate the ATSC 3.0 transition

Broadcast TV has been a consistently popular form of entertainment in the US, even with the onset of cable and satellite and, later on, streaming services. In fact, FAST (free ad-supported TV) apps on smart TVs and streaming platforms like Roku (Roku TV) and Amazon Prime Video (<u>FreeVee</u>), have gained considerable traction, which is a testament to the power of free TV channels.

The problem with FAST apps is that the quality is generally bad – certainly less than viewers have come to expect in the 4K era. And while all ATSC 3.0 stations are currently broadcasting in regular HD instead of 4K, a situation partly due to bandwidth limitations created by the FCC's simulcasting requirement, their ability to deliver higher-quality video and audio is compelling. Imagine being able to tune in sports in 4K – something you currently have to pay for a pricey cable or satellite TV package to experience. That was the case with the recent Super Bowl LVII, which was <u>transmitted in 4K with Dolby Vision HDR</u>, but only by cable provider Comcast Xfinity.

Pearl TV's FastTrack for NextGen TV program can help make free 4K sports and other programs happen by not just ensuring more new TVs coming to market are ATSC 3.0 compatible, but inexpensive external solutions such as ADTH's forthcoming USB tuner become widely available so that older, ATSC 1.0-only TVs can make the upgrade. A much broader ATSC 3.0 tuner base can only help float the ATSC 3.0 broadcasting boat.

ADTH's compact, under-\$75 ATSC 3.0 tuner plugs into a TV's USB port and receives digital TV broadcasts.



ADTH's Tolka-powered USB tuner solution seems to be an especially good one, and not just because it's cheap. Using the set's USB port for tuning digital TV broadcasts will free up HDMI ports on the set for connecting the <u>best</u> <u>4K blu-ray players</u>, <u>XBox Series X</u> or

<u>PlayStation 5</u> game consoles, and the <u>best soundbars</u>, and it eliminates the need for an external set top box.

Free ad-supported broadcast TV has life left in it – **as long as manufacturers keep making TV antennas, viewers will be buying them and plugging them into their sets**. But it's time for the broadcasting industry to make a big leap forward in quality to keep pace with streaming services, and that's something only a more rapid and complete transition to ATSC 3.0 can make happen.



KCFW 9 Kalispell, Montana Granted Move to Channel 17. Want to know why? Here is what they told the FCC:



Serious propagation problems associated with digital television broadcast (DTV) use of high-VHF television channels (7-13) remain unsolved. These are also well documented, both before and especially after the initial digital transition on June 12, 2009. These propagation and reception problems for channels 7-13 have been severe enough for the FCC to have broken the ERP limit in Zone I where the ERP limit for channels 7-13 is 30 kW at 305 meters HAAT, and has granted a construction permit for a

channel 7 facility with an ERP of 34 kW at 500 meters HAAT which met the FCC interference criteria. As a result this extraordinarily powerful authorized facility extends the distance to the noise-limited- contour by 19% and increases the predicted coverage area by 35.9% beyond the maximum distance and area permitted by the Rules in Zone I. And yet reception problems remain and continue to frustrate DTV broadcasters that use VHF channels, and a significant number of those station continue to struggle with propagation problems along with the subsequent viewer complaints. This proposal seeks to remedy this well known systemic problem in this instance by changing KCFW-TV's channel from VHF 9 to UHF 17, thereby providing its viewers with a significant improvement in reception capability.

KCFW-TV's licensee has determined that the proposed migration from channel 9 to channel 17 will be a favorable arrangement of allotments based on the enhanced signal levels that will be delivered to a majority of the population within the station's "protected service area". Note that a change to channel 17 results in a predicted increase of more than 38,800 persons in the overall potential viewer population while retaining the existing viewers of channel 9, except for a predicted loss of 75 persons, which is considered de minimis. The licensee believes that changing KCFW-TV to operate on channel 17 will solve most, if not all of its current reception problems.

KCBY 11 Coos Bay, OR Granted Move to Channel 34.

Here is part of their letter to the FCC:



The proposed channel substitution would serve the public interest because KCBY has had a long history of dealing with severe reception problems. The reception issues were exacerbated by the analog to digital conversion. This is not surprising as the Commission has long recognized that "VHF channels have certain characteristics that have posed challenges for their use in providing digital television service," including "propagation characteristics of these channels [that] allow undesired signals and noise to be receivable at relatively farther distances," and the fact that "reception of

VHF signals requires physically larger antennas that are generally not well suited to the mobile applications expected under flexible use, relative to UHF channels."3 The Commission has also stated that studies have found "large variability in the performance (especially intrinsic gain) of indoor antennas available to

consumers, with most antennas receiving fairly well at UHF and the substantial majority not so well to very poor at high-VHF."

These sound conclusions by the Commission have proven to be absolutely correct and are entirely consistent with the experience of KCBY operating on VHF Channel 11. Indeed, KCBY has received numerous complaints from viewers unable to receive the Station's over-the-air signal, despite being able to receive signals from other local stations. Permitting KCBY to operate on UHF Channel 34 instead of VHF Channel 11 will alleviate the Station's reception issues and will improve service to local viewers. Importantly, the proposal will result in more effective building penetration for indoor antenna reception and will also greatly improve the Station's ability to provide ATSC 3.0 service to homes, vehicles and portable devices, to the ultimate benefit of the Station's viewers and the public interest in the Coos Bay area.

K15FJ-D Lakeport, CA goes Silent. Something's Rotten in Lakeport

Their letter to the FCC states:

The shed enclosure for K15JF-D was installed at the tower site in the 1980s and was becoming rotted. Therefore, the old enclosure is being torn down and a new single rack outdoor enclosure is being installed. In order to remove the old enclosure, it was necessary to remove all the equipment. The new enclosure is planned to arrive onsite within a week. And, then the electric power will be connected and the enclosure bolted to the concrete slab and the equipment reinstalled.

WKNX-TV Channel 7, Knoxville, TN NPRM

The Video Division, Media Bureau (Bureau), has before it a petition for rulemaking filed on February 7, 2023, and amended on March 2, 2023, by Tennessee TV, LLC (Petitioner), the licensee of WKNX-TV, channel 7, Knoxville, Tennessee (WKNX-TV or Station). The Petitioner requests the substitution of channel 21 for channel 7 at Knoxville, Tennessee, in the Table of TV Allotments. (NPRM was adopted.) Interested parties may file comments, including counterproposals, on the NPRM in MB Docket No. 23-244 and RM-11955 on or before thirty (30) days after publication in the Federal Register and reply comments on or before forty five (45) days after publication in the Federal Register.




