GIVING IT AWAY! It's time to give away another great product. This time it's the newly remanufactured SBSP9 9-element FM yagi from Sky Blue Antennas. Just enter your name on the form and you will be in the running for this antenna. The drawing will take place around the end of September (before the next VUD arrives on your monitor, tablet or phone).

A quick note about the giveaway form. Ignore 'total entries','your entries' or "zero ways to enter" because these do not work in the free version of the form, which we use. If you are curious as to how many people entered the giveaway, just ask me. Usually we have around 50-60 people who enter our drawings. How many people want a new outdoor antenna is anyone's guess. Your odds of winning could be good!

THE LOGGER V2.0. The big thing this month is the relaunch of our own prop logger, called the WLogger. The logger is the creation of WTFDA member and software developer Bryce Foster. Bryce took ideas from WTFDA members and incorporated them into the new design for logger V2.

Some of the new features of the logger (in no particular order) are

- *Quick Find & Log (QFL). Enter the callsign of the station you want to log, click Find and QFL will find all of the other information for you. Then just click 'Submit' and it's logged. The mileage from your location to the station is displayed as well as azimuth and power.
- *Comments and discussion are now separate from the log section. Users can comment and chat in their own area to the right of the log section.
- *Manual logging. It's still there if you need it to log something unusual or not in the FCC or WTFDA databases.

*Stale logs. Old logs are no longer mixed with new logs. If a log is marked as 'stale', it is inserted in the proper order with other logs of the same date and time.

*Sleek new design. The logger has a great, new look! Here's a tease:



MONTREAL NEWS. Charly Gauthier in Montreal talks about HD and the TEF 6686: Yes, only 5 stations in HD. And further more, there is only one station from the Burlington-Plattsburgh market receivable at my Brossard QTH that is in HD (WVPS 107.9) but it's possible to eliminate the adjacent interference.. That is one of the reason I'm coming back to FM Dxing, the other being the discovery of the TEF 6686 radios, thanks to you and the VUD! Boy, do they perform well, so far I'm really impressed, so much so that I have bought now 4 of them. Planning to put one on the server eventually. This is why I bought the SBFM-9. I have assembled it, I hope to have it installed before the end of August, on one of my chimney (about 25 feet AG) with a Yaesu rotor. It should be fun, especially now that I have more time to myself! (Nearing the big 60 here).

And speaking of TEF 6686 radios, WTFDA member Bob Hawkins (Indiana) has set up his new webserver which can be found at http://207.135.223.250:8080. One of the more interesting stations I found when scanning the band with his webserver was WNAP 88.1, which is oldies but playing some unusual music. Bob told me he is on the air at WNAP from 6 to 8pm weekdays and from 10 to 2pm on Saturdays and Sundays. He also mentioned that WNAP's translator (W219DO) on 91.7 is located in his garage, as also is WYGB 100.3. So what's in your garage, eh?

WRDF STAYS ON CH12. Gray Television Licensee, LLC ("Gray"), licensee of Station WRDW-TV ("WRDW"), Augusta, Georgia, hereby requests that the Commission institute a rulemaking proceeding for the purpose of amending the DTV Table of Allotments.

WRDW successfully petitioned for a change to the Table of Allotments to specify UHF Channel 27 in place of its current VHF Channel 12 (File No. 0000127528) and was granted a construction permit for the Channel 27 facility (File No. 0000150357). However, WRDW is unable to complete construction of the Channel 27 facility within the time specified on the construction permit. WRDW therefore requests this amendment to the Table of Allotments to allow it to remain on its current VHF Channel. This proposal serves the public interest as it allows WRDW to remain on air, providing uninterrupted service to the viewers within its service area. I guess channel 12 was not so bad, after all.

And KGAN ch29 (visual 2) in Cedar Rapids, IA canceled their STA for reduced power and should be back up to their normal power of 275kw.

BERMUDA FM. Jim Thomas via WLogger chat wrote that he received an email from the chief engineer at Bermuda Broadcasting who said that they were recently authorized to increase their ERP from the Regulatory Authory of Bermuda from a 69 meter antenna height and that they are now running Power 94.9 at 2.5kw, Ocean 89.1 at 1.5kw and Inspire 105@ 1.5kw, which makes them the most powerful signals on the island. Will they ever be heard on the east coast via tropo?

2024 has gone down as the worst season I've experienced in the 32 years I have been DXing from my present location. For the first time since 2002, I did not receive any TV signals via E-skip. Tropo has been limited to mostly stations in the under-250 mile (402 km) range. I did log KHQA on their new RF channel, moving to 22 from 7. As of last check, WGEM has not yet moved from RF 10 to 19. My DTV total now stands at 226 in ATSC 1.0 format and one in ATSC 3.0 format.
