NEW MEMBERS. This month we welcome into the WTFDA four new members. A big welcome to all of you and we hope you find the club informative and interesting!



MONSTER TROPO. Chris Kadlec worked the whole opening and writes: On the evening of April 19th, a large high pressure system over the Atlantic spurred a fantastically strong opening from Bermuda to the southeast coast of the US. Reception in Bermuda included stations between Orlando and Hampton Roads along the coast and stretching - on average - about 150 miles inland. Intense conditions lasted until Sunday night midnight before abruptly waning, but quickly forming a few hours later centered over Orlando, Tampa, Jacksonville, and Savannah, where the opening remained on and off through the 24th. Almost every station in that area is 1,000 miles distant, most blasting with RDS.

While we've since had additional large tropo openings from Bermuda, including a major opening - albeit weaker and less widespread - on the night of April 30th, none have yet compared to that of Easter weekend. I stretched my body and mind to the limit to be present to document this opening as part of my own coastal propagation project, and managed to compile a total of 238 stations logged over the Easter holiday, the most distant being WAVH Daphne/Mobile at 1,376 miles with numerous others topping 1,200 miles. At times, others were present and helpful in logging and tracking down stations in a real impressive team effort.

It's hard to fathom, but 79 stations were received in excess of 1,000 miles! And the more you listen, the harder it is to comprehend as so many stations are regulars in Bermuda. A 1,000+ mile catch just becomes "Oh, it's them again in full RDS just blasting away. Yawn."

I have a full logs organized by time, distance, and frequency, 25 hours of audio from the past week of tropo, weather graphs, and more for those who are interested. A full report will be available next month to complement this summary.



Tropo wasn't just spectacular between the US and Bermuda, but the period around April 17 was really great for Mexican Dxers, with paths into Texas and also across the Gulf to Florida.

That's all for this month. We should be knee deep in skip by the end of the month so make sure your rotators are rotating and your 'tenna isn't falling apart before the skip hits. Let's hope this season is better than the last two were.

FCC Delete, Delete, Delete

The Federal Communications Commission has not been immune to President Trump's government shakeup. On March 12th, the FCC opened docket #25-133 – better known as "Delete, Delete, Delete". This docket asked for comments on every rule & regulation people felt the Commission should eliminate. Comments were due by April 11th. As I check on the 22nd, I see 939 comments filed – although many of them do not address broadcasting. (many were filed by hams, and telecommunications firms are also affected and have filed.)

Below are what I feel are the most important proposals. I read every comment that appeared to be filed by a broadcast interest. I may have missed some – many were filed by individuals, and I have no way of knowing if that individual was a broadcaster, a ham, or a consumer advocate. The most interesting ones are *in italics*.

Note the proposal (by public broadcasting interests) to eliminate the legal ID regulation! (frankly, while the DXer in me hates the idea, the broadcaster in me says this should have gone away decades ago...)

By service:

Full-service FM:

- Delete IF protection regulation, requiring minimum distance between stations separated by 10.6 or 10.8MHz.
- Delete 3rd-adjacent protection regulation, requiring minimum distance between stations separated by 0.6MHz.
- Allow use of distributed transmission systems. (multiple transmitters on the same frequency) These are already permitted for TV.
- Allow FM stations to use vertical polarization.
- Create "TIS-2" service on 87.9 FM.

LPFM:

- Allow power increase to 250 watts.
- Allow LPFMs operating for at least five years to upgrade to full-service non-commercial licenses.
- Allow LPFMs to sell airtime.

FM translators:

- Allow non-commercial translators to be fed by means other than off-air pickup even if above 92MHz.
- Allow FM translators to use up to 1,000 watts ERP or 20% of the primary station's ERP.
- Allow FM translators to use more than 250 watts if the tower is lower than, say, 50m.
- Allow FM boosters & translators to originate programming. Stations must still relay their primary at least 40 hours a week. Allow such stations to request four-letter calls with -FX suffix for example, W279CH to become WRFN-FX.
- Eliminate the requirement for FM translators to run legal IDs.

Shortwave:

- Eliminate the requirement that shortwave broadcast stations target only foreign audiences.
- Reduce the minimum powers for shortwave broadcast stations from 50kw to 5kw for analog operation; 1kw for digital; 100 watts for analog on the 11-meter band; and 20 watts for digital on 11 meters.

LPTV:

- Allow LPTVs to increase power to 25, 30, 50, or 1000kw UHF and 6 or 45kW VHF. (multiple proposals with different figures. One proposal would allow "low-power" stations to use as much power as full-license stations.
- Allow LPTV stations to use Distributed Transmission Systems multiple transmitters on the same channel.
- Eliminate the secondary status of LPTVs; prevent them from being "bumped" by full-service stations.
- Allow LPTV stations to opt out of participation in EAS.
- Require cable systems to carry LPTV stations.
- Allow all LPTV stations on channel 6 to add an FM audio service, not just the ones in the grandfathered list.

Full-service TV:

- Hold another incentive auction to finance a mandatory transition to ATSC 3.0. Use proceeds to cover:
 - Costs to stations to convert
 - Costs of viewer education campaigns
 - Vouchers for ATSC 3.0 TVs & converter boxes
 - Signal remediation services for unserved areas.
- Eliminate the must-carry regulations which require cable systems to carry the signals of any TV station reaching their subscribers.
- Eliminate limits on the percentage of the country's television households a company's stations can reach.
- Eliminate limits on the number of stations a company may own in any one market.

Stations in general:

- Allow non-commercial stations to sell airtime.
- Eliminate rule canceling license if off over a year.
- Reopen closed FCC Field Offices to improve enforcement.
- Replace station-count ownership limits with covered land mass, population, and/or number of nonoverlapping signals.
- Eliminate the station identification rule.
- Allow wireless microphones to operate in channel 37.
- Eliminate multiple-ownership regulations on AM stations, or on any station outside the top 100 markets.
- Create an expedited auction process when a license is canceled to speed return of service from a new owner.
- Require the federal government to pay for stations' EAS equipment.
- Allow non-licensees to reserve a callsign.

(Ed note: If a non-commercial stations sells airtime, doesn't that make it a commercial station? Could I make a proposal to eliminate incentive auctions? If an LPTV stations runs 50kw, is it still considered a low power station?)



Format Flips

and branding, too

Greetings! So many changes this month, you would think it was the beginning of the year. LOTS of changes in Canada this time around, as Bell Media has sold 45 stations to seven different groups. You'll see format changes related to this peppered throughout the column this month.

AL

Sweet Home Alabama may be a great song, but playing it non-stop for two days? That's how "Rock 100.5" WJRL Slocomb AL used the Lynyrd Skynrd hit to relaunch as "100.5 The Bear." They've also changed to new call WDAB. Two days. That's almost unbearable.

AZ

Adult R&B KOAS Dolan Springs AZ has flipped to Bilingual AC, and moved on from their previous branding as "Jammin' 105.7" to "105.7 Maxima." The station rimshots Las Vegas.

The "Hank FM" brand has landed in Tucson. Lotus Communications' Classic Country format is now on "93.3 Hank FM" K227DX Tucson. KLPX 96.1 HD3 feeds it.

AR

Rock "98.3 The Keg" is no more. KKEG Bentonville AR is now Classic Hits, positioning itself as "NWA's Classic Hits." Programming comes from Westwood One's Classic Hits 24/7 satellite feed.

BCN

South of the border, Grupo Cadena has made changes to a couple of their stations. XHMORE 98.9 Tijuana and XEWV 106.7 Mexicali are now Spanish CHR and known as "Party Mix."

BC

Vista Radio today announced revamps at the 21 stations it acquired in British Columbia. Classic Hits "Go FM" replaces the AC "Move" format at CILK 101.5 Kelowna, CJMG 97.1 CJMG Penticton and CHRX 98.5 Fort St. John.

A Classic Hits format known as "Summit Radio" replaces Variety Hits on several stations, including CKRX 102.3 Fort Nelson, CKGR 106.3 Golden, CKTK Kitimat, CKKC 106.9 Nelson, CKCR 106.1 Revelstoke, CKXR 91.5 Salmon Arm, CHOR 98.5 Summerland, and CJAT 95.7 Trail.

In Prince Rupert, CHTK 99.1 flips from Variety Hits to Classic Hits as "99.1 Coast FM."

In Kelowna, CHSU 99.9 goes from "Virgin Radio 99.9" to "99.9 Sun FM," retaining it's CHR format.

CICF 105.7 Vernon is now known as "The Ranch," and it's still Country.

Terrace's CJFW 103.1 maintains its Country format under the name "103.1 The River."

"The Goat" replaces "Bounce 101.5" on CKNL Fort St. John. That's due to a format change from Variety Hits to Rock.

CA

Another South Asian station is on in the Bay Area. It's a Franken FM, KBKF-LD 87.7 San Jose. The format is Bollywood Music and it goes by "Suno 87.7."

Fox Sports Radio has a couple new affiliates in California. KTMS 990 Santa Barbara and its translator, K250BS 97.9 Solimer Beach are now "Fox Sports 990 and 97.9," and KVTA 1590 Ventura and translator K250BV 97.9 Ventura are now "Fox Sports 1590 and 97.9." All of the stations involved dropped Conservative Talk for the new format. I'm not a big fan of FSR, even tho I work for an affiliate. Give me Sirius/XM's NHL Network Radio any day.

KVYB 106.3 Oak View CA has moved on from CHR as "106.3 The Vibe" to Oldies "Groovy 106.3." The Cumulus Media station is using Scott Shannon's True Oldies Channel programming following the demise of Westwood One's "Hits Now" network previously heard on the station. It's still the Oxnard/Ventura market's home for Dodgers baseball.

DC

A couple of Spanish language stations have rebranded to the name "Que Onnda." They are Spanish CHR WDCN-LD 87.7 Washington DC and Spanish AC W279DH 103.7 Haverhill MA. The Nueva Network stations were previously known as "DC 87.7" and "Exitos 103.7." The Exitos station is a translator for WCCM 1490 Haverhill.

IN

Star City Broadcasting's Country WYCM 95.7 Attica IN has moved on to Soft Oldies. New branding for the station is "MeTV Music 95.7." They're focusing on the 60's thru the early 80's.

KS

The name's the same, but the format is different. KZDY 96.3 Cawker City KS has flipped from AC to Classic Rock, while remaining "Z-96.3 The Lake." The new format will use programming from Local Radio Networks.

KY

Seven Mountains Media is making changes at another of its recently acquired stations. This time it's WKLX 100.7 Brownsville KY, which is now "BG 100.7. The station is Classic Hits, now positioning itself as "Big Hits." And here's something refreshing: they've dropped satellite programming for local origination.

MI

Hot AC "Hits 96.5" WTOU Portage MI has switched to Adult R&B, while W238AL Portage and its feeder station, WZOX 1660 Portage, adopts the Hot AC format. Not only are the formats swapping, so are the call letters. WZOX is widely heard by AM DXers on its expanded AM band frequency.

WGTO 910 Cassopolis MI has changed from Soft Oldies "97.1 MeTV-FM" to gold-based Hot AC as "97.1 The Ride." Owner Langford Broadcast Group blames MeTV-FM for not renewing their contract with the station. They're now using Miracle Media One's "Today's Mix FM" programming. This affects translators W244EO Dowagiac MI and W246DV 97.1 South Bend IN.

MN

Cumulus Media's legendary Classic Rock station, "92 KQRS" 92.5 KQRS Golden Valley, has had a facelift. Not that the format was ugly or anything, they just wanted to skew younger with more Classic Alternative and a highlight on Minnesota artists.

Townsquare Media may not have the number of stations iHeart and Cumulus do, but they tend to dominate the markets they're in. One such market is Duluth, where they've shifted Classic Rock "Sasquatch 92.1" WWPE Hermantown to Active Rock. They're positioning themselves as "Real Rock for the Northland."

MT

KHKM 98.7 Hamilton has gone Classic Hip Hop, calling itself "98.7 The Beat."

NB

In Atlantic Canada, New Brunswick to be exact, new owner Maritime Broadcasting has flipped several stations from Variety Hits to Classic Hits under the branding "The Wave." They include CKBC 104.9 Bathurst and CIKX 93.5 Grand Falls. Also, CJCJ 104.1 Woodstock flips from Country to "The Wave" Classic Hits.

NM

For two days they played Christmas music as "Santa 102.1." Now KYRN Socorro NM has flipped to Classic Hits under new call KNMQ. The station was previously "Mine Country 102.1." Actually, Classic Hits fill the airwaves weekdays while Classic Rock bombards listeners on the weekend.

NY

W277DR 103.3 Rome NY is now simulcasting Spanish Tropical W252DO Herkimer NY. It's quite a change from their previous Conservative Talk format.

NC

In North Carolina, Signal Hill Media Partners have started simulcasting their two Classic Country stations. "96.1 The Bear" WZGM 1350 Black Mountain and translator W241DD Asheville NC are simulcasting "Bigfoot Country" WBRM 1250 and translator W280FP 103.9, both Marion NC.

Also in the Tarheel State, W289CG 105.7 Goldsboro, fed by WFMC 730, and W225CD 92.9 Kinston, fed by WWMC 1010, have switched to Spanish CHR "La Ley." Both AMs simulcast WYMY 101.1 Burlington.

ND

KHTZ 106.9 Minot ND has no heart. Seriously. The former "106.9 The Heart" is gone, replaced by new owner RadioDifferently's new Classic Hits format known as "K-Hits 106." The station had been silent for financial reasons since last July. Why the change? Why not, Minot.

NS

Maritime Broadcasting has flipped two recently acquired stations in Nova Scotia. "Bounce 100.9" CKTO Truro has gone from Variety Hits to Classic Hits as "The Wave." And "Pure Country 99.5" CKTY Truro remains country but has gone back to its old moniker, "Cat Country 99.5."

OH

Adult R&B "Star 94.7" W234CH Girard OH is now "ESPN Mahoning Valley," as is the station it rebroadcasts, WGFT 1330 Campbell OH. I remember when legendary AM DXer, the late Jerry Starr, worked there. WGFT was WHOT back then.

ON

Bell Media's divesture of 45 stations to seven different companies also spreads to Ontario. My Broadcasting Corporation's CFLY 98.3 Kingston moves on from "Move 98.3" to its heritage name "98.3 Fly FM." Also in Kingston, "Pure Country 99" CKLC rebrands as "New Country 98.9."

In Brockville, CJPT 103.7 goes from Variety Hits to Classic Rock as "103.7 Giant FM," and AC CFJR 104.9 switches from "Move 104.9" to "104.9 My FM."

"Bounce Radio 92.3" CJOS Owen Sound ON has bounced to Soft Oldies as "Zoomer FM," matching the format and branding of co-owned CFZM 740 Toronto. They'll have local shows in the morning and afternoon during the week, and then duplicate 740's programming the rest of the time.

PA

Oldies "Z104" WWIZ West Middlesex PA, part of the Youngstown OH market, has switched from the now defunct "Good Time Oldies" network to AC. It's still using the "Z104" branding.

SD

In the Sioux Falls market, KQSF 95.7 Dell Rapids has switched from CHR to AC and KELO Sioux Falls has upped the tempo from AC to Hot AC.

TN



Great Plains Media's Cookeville Communications Conservative Talk "1400 The Hub," WHUB Cookeville TN, is now Christian AC as "107.7 Grace-FM." Obviously, they are more enamored with their translator, W299BY 107.7 Cookeville. The change came on Good Friday, April 18.

TX

No, you don't say! Hot AC "93.1 Yes FM" K226CH Lubbock TX is now "Young Country 93.1." It's still fed by the HD4 signal of KTTU 97.3 New Deal TX. It's anchored by the Bobby Bones show in the morning.

Contemporary Worship "Lift Worship" KGLY 91.3 Tyler TX is now simulcasting on co-owned KELW 95.3 Gilmer TX. KELW had been Christian Preaching "The Well," simulcasting 94.3 KZWL Bullard TX.

In the Abilene market, KTLT 98.1 Anson goes from Rock to AC. It's now known as "Abilene's Feel Good Station." KTLT had been using Westwood One's Rock 2.0 format.

UT

Country KUTQ 102.3 La Verkin UT has shifted to a more gold-based format as "Real Country 102.3." Previously, they were "Coyote 102.3."
