'Losing an icon': Long-running Lloydminster TV stations abruptly shut down

CKSA and CITL end broadcast run after more than 60 years

The owner of two local television stations in Lloydminster shut them down on Tuesday, abruptly terminating the jobs of 19 employees and ending more than 60 years of local broadcasting.

Stingray Group, a media conglomerate with several dozen radio and television stations across the country, announced the closure of CKSA-TV and CITL-TV in a staff meeting on May 13. A former employee who lost her job on Tuesday said on social media that there was no advanced notice of the shutdowns. The stations were closed down that day, denying the workers the opportunity to send out a farewell broadcast.

CKSA began broadcasting in 1960, while CITL launched in 1976. Both were affiliates for larger outlets including CBC, Global and CTV.

Steve Jones, the president of Stingray Radio, said the financial situation of the outlets had been deteriorating for years and became especially dire after the COVID-19 pandemic.

"It was an absolutely agonizing decision," he said. "The fragmentation of audiences across different digital and streaming platforms, and away from over-the-air television, has been a big factor. The migration of some advertisers over to digital has been a factor as well."

According to Jones, the stations' revenues declined by more than 50 per cent over the last six years.

Jones said Stingray spent months trying to find a buyer for the stations and that the company's regional manager for Alberta spoke to the mayor of Lloydminster about the closure.

But Mayor Gerald Aalbers disputed that claim.

"This was a total surprise," Aalbers said. "I would have certainly welcomed the opportunity to at least try and change their minds if that opportunity had been given to me. But it wasn't. So I was just in this much in the dark as the employees who got their news Tuesday morning."

Aalbers said people in Lloydminster, which straddles the Alberta-Saskatchewan border, and the surrounding communities will now have to rely on Edmonton and Saskatoon for local news.

"It was deeply, deeply saddening from the perspective that we're losing an icon in our city," Aalbers said. "It really rips the fabric of the community.

"How is community information going to be shared? How are sporting events being recorded and captured for the future? It just opens up a whole bunch of things from the perspective of the city's communications."

Aalbers also said the loss of the stations is indicative of the wider problem of local news decline in Canada.

"There's been a lot of conversation in the country about how we try and maintain Canadian media content," he said. "Certainly CBC, CTV, Global have all provided great coverage across Canada, but who fed you that information with a major event here in Lloydminster? It was our local TV station."

Lloydminster continues to have at least one local newspaper, the Meridian Source, and is still home to several local radio stations, including one owned by Stingray Radio. Jones said there were no plans to shut down any of Stingray's radio stations in the area.

The station closures follow years of local stations shutting down across the country. According to the Canadian Centre for Policy Alternatives, almost 2.5 million Canadians now live in a postal code with either one or zero local news outlets, double the number in 2008.

Private broadcasting outlets in radio and television have gone down by nine per cent since 2008, with closures at CTV and Corus driving a particularly strong decline in 2024.

For communities with fewer than 100,000 people, every province and territory except Ontario has seen an absolute decline in the number of local news outlets.

"It's really sad to me for the young journalists, and it's also really disappointing for those communities because I know how much what we did meant to them too," said Carly Agro, a former Sportsnet Host who launched her sports reporting career from CKSA.

"We were doing those communities and those people a really important service. We were telling them the stories and showing them the things that they really cared about," she said.

"If we weren't doing it, those things wouldn't get the attention that they deserved."

Armstrong Broadcast Returns to New Jersey in June

42.8 MHz will broadcast from the Alpine Tower for first time in a decade

The commemorative Armstrong broadcast station will return next month to 42.8 MHz in the New York City Tri-State area.



On Thursday, June 19, Steve Hemphill and the staff at the historic Alpine Tower in Alpine, N.J., will celebrate with a commemorative broadcast the 20th anniversary of the Armstrong Memorial event, which Hemphill originally organized in 2005 to honor the man who made FM radio possible, Edwin Armstrong.

Hemphill credited Alpine Tower owner Chuck Sackermann of CSC Communications, who allowed the first memorial broadcast to be conducted 20 years ago and funded most of the event's site logistics.

<u>WA2XMN</u>, the Armstrong Memorial broadcast station, will return to the air on June 19 beginning at 12 p.m., broadcast on 42.8 MHz — Armstrong's original low-band frequency. During previous transmissions, its signal



has been heard from as far as 100 miles away. Most police scanners can monitor the VHF low-band, as do software-defined radios.

The tower and original brick transmitter building were finished in 1937 to aid in Armstrong's FM radio experiments. The call sign is still etched in cement above the front door of Major Armstrong's original station building on the site today.



The Alpine Tower staff has worked to preserve the history of the site nestled in the Palisades of Bergen County — about 15 miles northwest of the Empire State Building. Fairleigh Dickinson University's Class B1 89.1 WFDU(FM) transmits from the Alpine. It was also used as an emergency site for several New York City TV and FM stations following the Sept. 11, 2001 attacks.

250 watts through a Phasitron

With hand-built vintage parts, Hemphill said his restored Phasitron transmitter, running 250 watts of power output, will feed into a Ringo vertical antenna mounted on the Alpine Tower at approximately 400 feet above ground level. Transmissions of the experimental station are in wide-band frequency modulation, using the same technical standards as modern FM broadcast stations.

"Although the Phasitron was not even invented yet when Armstrong began his broadcasts, the technology is approximately correct for the era," Dave Hershberger wrote in his 2004 profile of Hemphill's reenactment.

Hemphill said he will be broadcasting programming from the 2005 event, which includes their original Armstrong panel discussion and interviews with Major Armstrong's niece, Jeanne Hammond, and Tom Lewis, author of "Empire of the Air." He will also be airing David Osman's production of "Empire of the Air: The Men Who Made Radio," based on Lewis' book.

Hemphill added that he is planning a collaboration with Kirk Harnack's "<u>This Week in Radio Tech</u>" podcast as part of the 42.8 MHz coverage.

He said that plans to stream online coverage of the 42.8 MHz broadcast are still being discussed.

The last time WA2XMN broadcast was in 2015, Hemphill said. A 2018 broadcast to honor Hammond — who had recently passed away — was cancelled due to problems with the station antenna's transmission line.

The Radio of Club America honored Hemphill with a Special Appreciation Award in 2005 for the 70th anniversary broadcast. A consulting engineer since 1969, he is the founder of Solid Electronics Labs, which manufacturers and sells FM broadcast exciters and stereo generators.

WIRO Radio Returns to Ironton



A southern Ohio company gave Ironton an early "Christmas gift" Wednesday morning by returning a heritage radio station to the local community—complete with holiday music. "Ho Ho Radio" made its debut on 107.1 WIRO-FM this week on a radio signal that has not featured local programming for several decades now.

Gary Mincer, vice president and general manager of Total Media out of Jackson and a 40-year radio professional, said the new station will provide the soundtrack of the season from Thanksgiving until Christmas. After the holidays the company will kick off the new year with 107.1 WIRO-FM with J.B. Miller at the helm in morning drive, 6-10 a.m. Monday through Friday.

"I'm not going to divulge what (format) we're going to (after that), but just know it will be hyper-focused on Ironton—sports, local news, happening events and fun," Mincer said. "We're going to surprise everybody after the holidays with a new format."

There's a party on the air in the Orlando market. WONQ 1030 Oviedo FL and translators W230AL Union Park and W278CN Eatonville are now known as "Party FM. The format is Bilingual Rhythmic CHR, with the station billing itself as "Central Florida's hottest bilingual station with today's hits."

Legendary group owner Hubbard Radio has done away with its CHR "Party 96.3" brand on W242Cl 96.3 Jupiter FL in favor of using the translator to rebroadcast its Conservative Talk station WFTL 850 West Palm Beach. The move gives the area its first conservative FM talker in the area.



The AM/translator combo of WROD 1340 and W283DS 104.5, both Daytona Beach, has flipped from Rock to Conservative Talk. The pair is now known as "The Talk of Daytona."

ID

Rich Broadcasting's Hot AC "Star 98," KGTM 98.1 Shelley ID, and KLLP 98.5 Blackfoot ID, have both switched to Classic Hits. The two still go by "Star 98," but they're now positioning as "The Best of the 80's, 90's and more."

IL

WXAJ 99.7 Hillsboro IL has traded Hot AC for Classic Hits, going from "99.7 The Mix" to "99.7 CVS." And they've brought back legendary call letters for central Illinois by switching to WCVS. And no, it has nothing to do with the pharmacy chain.

IA

A lot of stations use Christmas music to stunt before changing formats, but in May? KMCS 93.1 Muscatine IA did just that, bridging the old Rock format as "93.1 The Buzz" and the new Adult Hits format as "MC 93." Music is from the end of the last century from "Muscatine's Choice for Music."

ME

WXME 780 and it's translator, W252DW, both Monticello ME, have switched from AC as "98.3 The Mix" to Oldies as "98.3 The Ride." Sounds like it'll be a fun ride for the folks there. Music is from the 50's, 60's and '70's. Nice to see a station include '50s music.

MD

Life has ended for the Maryland Christian AC trio known as "Life FM." W232DG 94.3 Frederick, W271BV 102.1 Hagerstown and WWEG-HD2 106.9 Myersville have flipped to Soft Oldies as "Fred-FM." The 3 focus on Yacht Rock and R&B.

NV

In northeast NV, Classic Country "True Country 100.5" K263BD Spring Creek has flipped to Rock as "Overdrive 100.5." It's still fed by KBGZ-HD4 103.9 Spring Creek.

OH

The silence is broken in Manchester OH, as WAGX 101.3 has returned to the air with Classic Country as "101.3 Hank-FM." The station had been off the air since May 2024 after owner James Wagner was unable to run the station due to Alzheimer's. Seems to me many stations, AM and FM, have gone off or been sold in the last few years after the death or serious illness of an owner. Being older, I guess I notice that stuff more.

WNNF 94.1 Cincinnati has rebranded, dropping "Cat Country 94.1" for "94.1 WNNF."

WREO 97.1 Ashtabula OH has changed up its format, going from Adult Contemporary "Lite Mix 97.1" to Classic Hits as "Mix 97.1." Positioning itself as "The North Coast's Best Mix," WREO has a wide variety of songs from the 60's through the 90's. I keep wanting to put Speedwagon after those call letters.

OK

OKC based Tyler Media has pulled the plug on one of its plethora of HD fed translators. Spanish AC "Exitos 96.5" K243BJ Oklahoma City, fed by KRXO 107.7 HD3, has exited, replaced by Spanish CHR "Ritmo 96.5." it's positioning itself at "Pop Latino y Más."

ON

A local non-profit has saved a couple Ontario stations from deletion. La Radio Communautaire Cornwall-Alexandria agreed to acquire CHRC 92.5 Rockland and CKHK 107.7 Hawkesbury last September after Evanov Communications planned to 86 both stations. The two stations are now Variety Hits as "Big-FM." Per Ontario member Peter Laws, "CHRC-92.5 is in Clarence-Rockland, at the other end of the county and adjacent to the City of Ottawa, Ont ... is totally overpowered by Montréal's CKBE-92.5 The Beat, a Cogeco operation. When I was a kid, they were CFQR and it was all easy listening/beautiful music. Now it's all poppy/dancy. :-) Did I mention 107.7 is more Classic Rock/Classic Hits? Yeah, listening to that instead. :) Next time I go west in the car, I'll take a listen to 92.5 and see what they're like." Peter did confirm that 92.5 has indeed changed.

CKPT 99.7 Peterborough ON has moved on from its identity as "Move 99.7." It's now Adult Hits as "Pete 99.7," positioning themselves at "Peterborough's Playlist." It features tunes from the '80s til now. Perhaps they should be carrying Peterborough Petes OHL games rather than CJMB.

SC

In less than a year "Fox Sports 94.7" WAAW Williston SC has worn out its welcome and is returning to Gospel as "Shout 94.7." The legendary James Brown once owned WAAW.

Does it really take three broadcasting companies to run a translator? In Greenville SC Norsan Media is now operating Salem Communications' W275BJ 102.9 and rebroadcasting Audacy's WROQ-HD2 101.1 Greenville. Programming is Spanish CHR with a mix of music aimed at Caribbean and Central American listeners. It gives Norsan 4 Spanish signals in the market.

WDXI 1310 Jackson and it's translator, W278CL 103.5 Savannah TN, have switched from Conservative Talk to Fox Sports Radio. It's now known as "Talk-N West TN Sports."

Oldies from the 60's and '70s are now heard on WCLE 1570 and W256DQ 99.1, both in Cleveland TN. Owner Hartline LLC flipped the stations from Regional Mexican "Fiesta 99.1" to "Cleveland's Oldies 99.1."

WI

Up in the northlands of Wisconsin the Lac Du Flambeau Band of Lake Superior Chippewa Indians have signed on the new WLDF 92.9 Lac Du Flambeau. The format is Adult Alternative branded as "The Torch." Sounds like a hot new station. Beautiful country up there. I recall camping in nearby Minocqua as a teenager.

Here's something special to wrap up the column for this month. For full transparency, I'm an employee of iHeartMedia in Oklahoma City. Give a listen to our new jingles for KJYO 102.7, better known as KJ-103. Note the use of the actual frequency, not just 103. There's now a Tyler Media translator on 103.1 here playing hip-hop. This is from Lance Venta's Radio Insight.....

ARMSTRONG BROADCASTING RETURNS continued from page 5 **History of the Palisades**

The Armstrong — or Alpine — Tower is the site of the world's first FM broadcast station, W2XMN, broadcasting primarily on 42.8. It first signed on in 1938 and broadcast until July 1949, when the FCC shifted frequency allocations to 88-108 MHz band we know today.

Hemphill also noted Major Armstrong's "high-band" FM broadcast station. It signed on in 1945 with the callsign W2XEA on 92.1 MHz. It moved to 93.1 in 1948, with the KE2XCC callsign. That station broadcast until March 1954 when it signed off a month after Armstrong died.

It was 90 years ago when the pioneer who made FM radio possible put forth the first public demonstration of the technology. According to Columbia University — where Armstrong graduated with an electrical engineering degree — he described FM radio and then turned on his receiver in front of the audience during a November 1935 Institute of Radio Engineers conference.

An FM transmission from a friend's house in Yonkers came in free of static with a fidelity never heard before.
